**ROAD SAFETY IMPROVEMENT WORKS
AT BROOKLODGE GROVE, GLANMIRE**
Notice Under Section 38 of the Road Traffic Act 1994

Pursuant to the provisions of Section 38 of the Road Traffic Act 1994, Cork City Council hereby gives notice of its intention to carry out traffic management measures in the interest of the safety and convenience of road users at Brooklodge Grove, Glanmire.

Cork City Council proposes to carry out various measures to improve pedestrian and cycling infrastructure and facilities along Brooklodge Grove (L3010). The main features of the proposed scheme are:-

- Removing one way vehicular access to Brooklodge Grove from L3010 and L2997.
- Improvements to L3010/L2997 Junction and footpaths to enhance safety for pedestrians and cyclists.
- Provision of turning bay for vehicular traffic on Brooklodge Grove.
- Provision of uncontrolled pedestrian crossing on L3010.
- Other necessary associated ancillary works.
