## NOTICE UNDER SECTION 38 OF THE ROAD TRAFFIC ACT 1994 (AS AMENDED)

## SAFE ROUTES TO SCHOOL – St Lukes National School

Pursuant to the provisions of Section 38 of the Road Traffic Act 1994 (as amended), Cork City Council hereby gives notice of its intention to carry out various safety improvement measures to improve pedestrian and cycling infrastructure and the front of school environment at St. Lukes National School, Mahony's Avenue, Monetnotte, Cork, as part of the Safe Routes to School programme.

The main features of the proposed works are as follows:

- Decommissioning of the existing left slip lane from Glanmire Road Middle to Summerhill North by use of planters/pencil bollards, reducing pedestrian vehicle conflicts.
- Trimming of the existing traffic island to facilitate a wider radius for left turning vehicles.
- The provision of a raised table Pelican crossing on Summerhill North.
- The provision of a raised table uncontrolled crossing at Mahony's Avenue North to facilitate traffic calming.
- The reallocation of existing on street parking to the left side of carriageway on Mahony's Avenue.
- The introduction of a one-way traffic system, flowing South to North of Mahony's Avenue.
- Widening of the existing footpath from the Front of School area up to the proposed crossing areas on Mahony's Avenue.
- The provision of road markings to highlight a shared cyclist/vehicle carriageway on Mahony's Avenue.
- The provision of advanced warning signage, road markings and high friction coloured surfacing, on the approach to the Front of School Gateway, as a means of calming traffic in the interest of cyclist and pedestrian safety.
- Relining of the existing Yellow Box Road Marking at St. Lukes Cross.
- The provision of build outs along Mahony's Avenue to facilitate traffic calming.
- Road realignment including narrowing of the carriageway to facilitate traffic calming.
- The provision of a raised table Zebra crossing on Wellington Road.
- Other necessary associated ancillary works.

In accordance with the Habitats Directive, an Appropriate Assessment (AA) Screening has been carried out on the proposed scheme, in relation to any potential impacts upon the Cork Harbour Special Protection Area [Site No. 004030] and the Great Island Channel Special Area of Conservation [Site No. 001058]. The findings of the AA screening noted that no significant effects on any Natura 2000 sites are likely, and it was not necessary to undertake any further stage of the Appropriate Assessment process. In addition, the proposed scheme has been screened to determine whether an Environmental Impact Assessment (EIA) is required, and it has been concluded that there will be no real likelihood of significant effects on the environment arising from the proposed scheme and that an EIA is not required.

Accordingly, they will be included in the minutes of that meeting and may appear in the public domain. Cork City Council will retain data for no longer than is necessary and in accordance with the Council's Retention Policy and relevant Data Protection legislation.
